This estate's luxury cuvee of 100% Syrah, fermented in new oak and bottled unfiltered, is the equivalent of Hermitage made in Provence. The black/purple color and fragrant bouquet of sweet black fruits, bacon, and Provencal herbs are impressive. Long and full-bodied, with an unusual sweetness to its fruit, this exotic, super-concentrated wine possesses adequate acidity and a blockbuster finish. Voluptuous and rich, this is a wine to drink over the next 10-12 years. Very impressive!
